



The City of Martinez and the developer of the Traditions Subdivision, DeNova Homes, are preparing plans for the first phase construction of a **new park at Pine Meadows Drive**, located at the site of the former Pine Meadows Golf Course. Approximately 8 acres of has been dedicated for open space and park use as part of the residential subdivision development located north of Center Avenue and east of Morello Avenue. The park will be adjacent to the new street Pine Meadow Drive.

The first phase of the new park project will include access points and pathways through the open space areas of the park, a nature trail and with landscaping, accessible parking, recreational turf areas, and site amenities such as an all-abilities playground, restroom, picnic area and tables.
